



In pursuance of the Hon'ble High Court Judgement dated 05/09/2006 in Civil Writ Petition No. 23749/2005 in the matter of Mrs. Urmila Devi Vs. CSIR & Anr, and acceptance of the same by CSIR vide letter No. 36-13 (145)/2003-Law dated 03/10/2006, meeting of the Compassionate Appointment Committee was held on 4/10/2006 and two cases of Sh. Ravi kumar S/o Late Sh. Gridhari Lal, Helper Grade-II and Smt. Urmila Devi W/o Late Sh. Sunil Kumar, Helper-B were considered for making appointment on compassionate grounds, as per the directive of the Hon'ble High Court. In order to have the latest status with regard to financial conditions and dependents family members, the Committee called Smt. Jai Wati W/o Late Sh. Girdhari Lal, Helper Gr. II and her son Sh. Ravi Kumar and obtained a written statement to that effect (Annexure—II). As regards case of Late Sh. Sunil Kumar, Helper-B the committee noted the information given in the Annexure-1 that she had only one dependent son aged 8 years and mother-in-law aged 74 years as on date. The committee found that both the families of Late Sh. Girdhari Lal and Late Sh. Sunil Kumar were in receipt of almost same amount of family pension i.e. Rs. 3395/- p.m and Rs.3116/- p.m respectively as on 30/09/2006 and

almost received same amount of retirement benefits as revealed in Annexure-I. As regards the dependent family members, the committee noted that as per the detailed provided by the family that the Late Sh. Girdhari Lal had survived by wife aged 50 years, two unmarried daughters aged 17 years & 13 years and two sons aged 15 years & 20 years old whereas the Late Sh. Sunil Kumar had survived by wife 32 years old, son aged 4 years old and mother aged 70 years old.

The Committee viewed that since the wife of Late Sh. Girdhari Lai had four dependent family members which included two unmarried daughters now aged 22 years & 16 Years, and two sons aged 19 years and 26 years as compared to Smt. Urmila Devi W/o Late Sh. Sunil Kumar, Helper-B who had only two dependent members one son aged 08 years and mother-in-law aged 74 years, the case of Late Sh. Girdhari Lal was more deserving than the case of Late Sh. Sunil Kumar. The Committee noted that Sh. Ravi Kumar possessed the 8th passed educational qualification and was 21 years age at the time of submission of application and thus recommended Sh. Ravi Kumar S/o Late Sh. Girdhari Lal for appointment to the post of Group-D (Non- Technical) on compassionate grounds.

Sn. Jitender Parasar, COA, CRRI did not attend the meeting as he was on official tour.

The Compassionate Appointment Committee perused applications as well as particular of candidates (enclosed as Annexure-1) who are due for consideration of appointment on compassionate grounds. They discussed the cases at length. The vacancy position (placed before the Compassionate Appointment Committee vide Annexure-II) of one vacant post to be filled up on compassionate ground was informed by Personnel Cell, CRRI verbally. The committee proceeded further assuming existence of one post to be filled on compassionate appointment basis.

The compassionate Appointment Committee gives its recommendations which are as follows:-

On consideration of all the applications, the committee viewed that since the wife of Late Sh. Vikram Negi, Gr.I (4) had four dependent family members which included two unmarried daughters, one son and aged mother-in-law and Sh. Sh.Vikas Singh S/o Late Sh. Vikram Singh Negi, Gr.I (4) possessed 12<sup>th</sup> pass educational qualification and thus recommended Sh. Vikas Singh Negi S/o Late Sh. Vikram Singh Negi for appointment to the post of Assistant (F&A) Gr.III on compassionate grounds.

Further, following cases may be considered in the next meeting of the compassionate appointment committee since at this time only one vacancy exist for making appointment on compassionate grounds:-

- 1. Sh. Rinku S/o Late Sh. Ram Gopal, Gr.I (4)
- 2. Sh.Mahesh Kumar S/o Late Sh. Suraj Gr.I (4)
- 3. Ms. Nancy D/o Late Sh. Suresh Kumar, Gr.I (4)
- 4. Smt. Sunita W/o Late Sh. Satish Kumar, Gr.I (4)

The Committee further feels that as per instruction on the subject, the following cases are not fit for further consideration as all the cases are more than 3 years old. Compassionate appointment is largely related to the need for immediate assistance to the family of the government Servant in order to relieve it from economic distress. The very fact that the families has been able to manage somehow all these years was taken as adequate proof that the families had some dependable means of subsistence.-

Keeping in view of the above observation, the CAC was of the unanimous opinion that it will give immediate preference to cases where 5 years or less have elapsed from the date of death of deceased.

The CAC had also noted the observation made in DoPT OM bearing No.14014/3/2011-Estt.(D) dated 26.07.2012 wherein it has been stated that "The primary objective of scheme for compassionate appointment circulated vide OM No.14014/6/94-Estt.(D) dated 09.10.1998 is to provide immediate assistance to relieve the dependent family of the deceased or medically retired Government servant from financial destitution".

Therefore, the case of Smt. Sunita Rani, who is the widow of Late Sh. R.C. Joon, who expired on 26.07.2016 falls within this category.

It was also discussed in the earlier meeting of the CAC held on 03.08.2018 that preference should be given to the wife of the deceased for compassionate appointment because if the widow of the deceased is granted a compassionate appointment then she would be empowered to look after the whole family including a children.

The case of Smt. Sunita Rani, also falls within this category since she has 2 dependent children to look after, both of which are unemployed.

The family pension which is being received by Smt. Sunita Rani W/o Late Sh. R.C. Joon, is Rs.45900/-. The DCRG has not been paid in respect of Late Sh. R.C. Joon, but as and when it will be disbursed, it will come to Rs.20 Lakhs. An RGIS payment of Rs.1,80,000/- has also been disbursed. The leave encashment to be paid to Late Sh. R.C. Joon is Rs.7,46,550/-. The family does not have any Flat or House and presently staying in CRRI Staff Colony. However, a small Plot measuring 87 Sq. Yards was purchased by Late Sh. R.C. Joon in an unauthorized area in Najafgarh which is on General Power of Attorney (GPA) and therefore, is not a registered property.

Moreover, for the medical treatment of Late Sh. R.C. Joon, a loan of Rs.18,00000/-(Rs. Eighteen Lakh Only) was taken by his family from the market, friends and relatives which is yet to be paid back.

Further it is also submitted that the Cabinet Secretariat, Rashtrapati Bhawan, had issued instructions on 7<sup>th</sup> April, 2015 to fill up all positions pertaining to PwDs in all Govt. of India Departments/Autonomous Bodies within a period of 4 months. The same was endorsed by CSIR to all the Labs./Instts. vide their letter No.19-1(7)/2014-SC/ST Cell (PwD) dated 17.04.2015. Subsequently reminders were sent to all Labs./Instts. of CSIR vide Office Memoranda dated 06.05.2015, 05.08.2015 and 07.10.2015 (copies enclosed).

Smt. Sunita Rani widow of Late Sh. R.C. Joon deserves to be given compassionate appointment at CRRI due to the following reasons:-

 Smt. Sunita Rani, has 2 dependent children. One is an unmarried daughter and the other one is a son who is studying in BA (1<sup>st</sup> Year). Even though she

is a person with 40% disability for which she has submitted a certificate of the Medical Board of Dr. Ram Manohar Lohia Hospital, New Delhi dated 05.10.1994, and is therefore, a PwD candidate, she is herself applying to get employed in CRRI in order to make two ends meet under such compelling circumstances.

- By giving compassionate appointment to the wife of Late Sh. R.C. Joon, who is also a mother of two children, the whole family can be looked after and both the unmarried daughter and son can pursue their education.
- As brought out earlier, Smt. Sunita Rani does not have any arrangement for living on their own and hence taking into account the available resources at the disposal of the family she will have to incur additional monthly expenses on rent also.

### Self-Contained Note in respect of Sh. Ankit Kumar, S/o Late Sh. Harish Kumar

Sh. Harish Kumar, was working as a Sr. Technician (Civil) who expired on 23.03.2018. The dependent family members of Late Sh. Harish Kumar are as follows:-

Smt. Pushpa – W/o Late Sh. Harish Kumar, aged 49 yrs.

2. Sh. Ankit Kumar, S/o Late Sh. Harish Kumar, aged 24 yrs.

3. Ms. Tanya, D/o Late Sh. Harish Kumar, aged 21 yrs.

It is submitted that Sh. Ankit Kumar, is pursuing M.Com and is presently unemployed. However, to sustain his education, he has been giving Home Tuition from which on an average he is able to earn approximately Rs.9000/-, which is commendable. However, this is not a fixed income. Therefore, in reality, he has no regular source of income.

In respect of Ms. Tanya, D/o Late Sh. Harish Kumar, it is submitted that she has competed Class XII and is unemployed with no source of income.

Smt. Pushpa, W/o Late Sh. Harish Kumar, is a house wife and is also unemployed.

The only source of subsistence for the family is the family pension being given to the family of Late Sh. Harish Kumar. They have submitted an undertaking in a non-judicial stamp paper to the effect that Smt. Pushpa, W/o Late Sh. Harish Kumar, has no objection for the consideration of her son Sh. Ankit Kumar, for compassionate appointment.

It is further submitted that as per the caste certificate issued by the office of the Deputy Commissioner, South District Delhi, he belongs to the Scheduled Caste category.

However it is submitted that since the deceased has left behind 3 dependents and none of them are employed, the family is only subsisting on the family pension of the Late Sh. Harish Kumar.

Late Sh. Harish Kumar expired on 23.03.2018 and in the earlier meeting of the CAC held on 03.08.2018, a reference was invited to the judgement of the Hon'ble Supreme Court of India, dated 05.04.2017 in Civil Appeal No.2206 of 2006 filed by Local Administration Department Vs. M. Selvanayagam @ Kumaravelu, wherein the Hon'ble Supreme Court has observed as follows:-

#### Quote

"an appointment made many years after the death of the employee or without due consideration of the financial resources available to his/her dependents and the financial deprivation caused to the dependents as a result of his death, simply because the claimant happened to be one of the dependents of the deceased employee would be directly in conflict with Articles 14 & 16 of the Constitution and hence, quite bad and illegal. In dealing with cases of compassionate appointment, it is imperative to keep this vital aspect in mind"

### 5.2.1 Road Parameters

- Bus Lane: A lane on the urban road reserved primarily for buses during specified periods
- Bus Stop: An area in which one or more buses stop to enable loading and unloading of
- Road Width: It is the paved width of the road with or without shoulders available for
- Divided Road: A two-way road on which traffic movement is segregated direction-wise by movement of vehicles. physical separation
- Effective Road Width: It is the width of the road that is effectively used for vehicle movement
- out of the total road width available Frictional Resistance / Elements: The activities on the roadside that are likely to influence the carrying capacity of the road section are considered as a frictional element e.g., Bus bay, access road, roadside parking, etc.
- Kerb: It is a vertical or sloping member along the edge of a pavement or shoulder forming part of a gutter, strengthening or protecting the edge, and clearly defining the edge to the drivers.
- Link: A link represents a length of roadway between two points.
- Median: The physical feature that separates the two directions of opposing flow on divided
- Point: A point represents the boundary between links and usually indicates an intersection or a ramp terminal.
- Segment: A link with its boundary intersections is referred to as a segment.
- Segment Length: It represents the distance between the boundary intersections defining the
- Shoulder: The additional paved width available for on-street parking and vehicle movement during certain periods.
- Side Friction: The physical features that are likely to impede the traffic flow.
- Undivided Road: A road with no median or any form of physical feature to separate the opposing traffic streams.
- Urban Area: An area typified by high densities of development or concentration of population, drawing people from several areas within a region.

#### 5.2.2 Traffic Characteristics

- Annual Average Daily Traffic Volume: The total yearly traffic volume in both directions of travel divided by the number of days in a year.
- Average Daily Traffic Volume: The total traffic volume in both directions of travel during a time period more than one day but less than one year divided by the number of days in that
- Basic Capacity: It is the maximum number of vehicles that can pass a given point or section of road on a lane or roadway, during one hour under the most nearly ideal roadway and traffic conditions which can possibly be attained.
- Capacity: It is the maximum number of vehicle per unit of time that can be handled by a particular roadway component under the prevailing roadway and traffic conditions.
- Density: It is the number of vehicles present on unit length of road at any particular instant of time. It is usually expressed in vehicles per kilometer
- Free Flow Speed: The mean speed of standard cars that can be accommodated under low to moderate flow rates on a road segment under prevailing roadway and traffic conditions

#### Urban Roads

[HCM, 2010]. Free Flow Speeds may be measured for a given vehicle when the traffic flow is such that the time gap between two consecutive vehicles is more than 8 seconds.

- Flow Rate: It is a macroscopic flow parameter defined as a number of vehicles passing a point in a given period of time. It is usually expressed as hourly flow rate.
- Jam Density: It refers to extreme density associated with completely stopped traffic flow.
- Lane Capacity: The traffic capacity of a lane of an urban road.
- Lane Configuration: Lane configuration of an urban road is defined as the total number of lanes available for traffic movement.
- Level of Service (LOS): It is a quality measure describing the operational conditions within a traffic stream, generally in terms of service measures such as speed and travel time, freedom to manoeuvre, traffic interruption, comfort, and convenience. The LOS for basic roadway segment is based on the traffic density expressed in Passenger Car Unit per kilometre (PCU/ km) and Vehicles per kilometre (vehicles/km).
- Occupancy: The physical area occupied by the vehicles on the road section relative to the total road area available.
- Operating Speed: It is the speed at which drivers are observed to operate their vehicles under Free Flow Speed (FFS) conditions.
- Passenger Car Unit: Passenger Car Unit (PCU) is a universally adopted unit used for capacity analysis of a roadway system having heterogeneous traffic condition. The PCU value of a small car is identified as one. The interaction of vehicles in the traffic stream is represented in terms of Passenger Car Unit (PCU), which is the amount of impedance caused to flow of traffic by other vehicle types (Refer Annexure 5A) in comparison with that of car.
- Peak Hour Factor: A ratio of the volume occurring during the peak hour to the peak rate of flow during a given time period within the peak hour (typically, 1 hour, 15 minutes or 5 minutes).
- Prevailing Condition: The geometric, traffic and control conditions observed at the study
- Space Mean Speed: The harmonic mean of vehicle spot speed observed over a road segment. An average speed based on the average travel time of vehicle to traverse a segment of roadway.
- Service Flow Rate: The maximum rate of flow that can be maintained for the analysis period under the prevailing roadway and traffic conditions.
- Side friction Adjustment Factor: It is the factor which incorporates the effect of side friction
- on the road capacity. Stream Equivalency Factor: It is the ratio of traffic volume in PCUs per hour to volume in
- Vehicle Headway: It is the elapsed time between the arrival of the leading vehicle and the
- following vehicle at a designated test point. Volume: The number of vehicles passing an observation line expressed in vehicles per hour.
- Volume to Capacity Ratio: The ratio of flow rate to the capacity of a road segment.


